2020 HIGHLIGHTS



HEART'S PLACE OCCUPIED.

Heart's Place in Arlington Heights was fully leased and provides 18 units of supportive housing to individuals living with a disability.



CARY SENIOR LIVING COMPLETED.

Construction was completed on the 62 unit Cary Senior Living. The project received green certification.



SPRUCE VILLAGE BUILT.

This 44 unit supportive housing development in Palatine was under construction for all of 2020. Staff began leasing from a 200 person wait list.



CLELAND PLACE CONSTRUCTION BEGUN.

Financing was closed and construction began on this new 16 unit family project in Wilmette at the end of 2020 and will be completed in 2021.

BROADVIEW SENIOR UNDER CONSTRUCTION.

In partnership with Ross Financial, Broadview Senior, a new 70 unit senior development, in Broadview began construction in 2020.

RENTAL BUILDINGS MANAGED.

HODC currently manages 349 rental units at 24 locations in ten suburban communities. Service Coordinators work with over 100 tenants with disabilities.

Thanks to your generous contributions in the last year, you have made an impact on the lives of our residents. As partners, we have made it possible for them to enjoy the safety, stability, and community of a permanent, affordable home. Together, we are building a better world.

The year 2020 will go down in history as one of the most challenging due to COVID-19. The resilient staff and board of HODC found ways to keep our residents and themselves safe, from vigilant cleaning, wellness checks, help with accessing rental assistance funds, continuity of our rental, maintenance, and service functions, to adding new directors to our board, and updating our Strategic Plan. Having a home has never been more important. I am excited to tell you that HODC found a new home at 5340 Lincoln Avenue in Skokie. Not only does this move offer security of ownership, but it also provides space for our growing organization. The building will be named for Richard Koenig, our Executive Director who has been the driving force for the organization since 1997. We look forward to celebrating with all of you at an Open House as soon as it is safe to do so.

Even as we managed the pandemic, the HODC board turned its attention to the future and our Strategic Plan. Implementation of 3 key goals is underway: improve our public outreach through enhanced communications; build board capacity to strengthen our governance; and build an additional 200 units over the next 3 years (increased from the former goal of 300 units by 2027). With the opening of Spruce Village (44 units), 86 more under construction (16 in Wilmette and 70 in Broadview), and 26 approved for financing, we feel confident in our ability to do more, so we must do more. We could not have achieved this without our determined staff and Volunteer of the Year, Pete Peyer, who brought his development experience with the Village of Skokie to HODC.

You are invited keep an eye out for future updates to our website and follow us on social media to learn more and stay informed about our projects. You can help us fight housing insecurity as ever increasing housing prices in the northern suburbs cause more hard-working families, seniors and the individuals living with a disability struggle to make ends meet. The average time on a waiting list for affordable housing runs two to five years with many waiting longer. We believe everyone should have access to a home they can afford in a community of their choice.

Debra worked full time for most of her life until chronic health issues made it difficult to stay employed. "When the pain gets real bad, I just stay positive. I tell myself, 'The mind controls the body,' and I just keep moving."

Debra's family has strong ties in the Evanston community. Her grandmother regularly worked to feed the local homeless community. Her grandfather was a well-known local chaplain who also worked for the prominent Wrigley family. Debra grew up in Evanston walking past the building that would become her future home, HODC's Claridge Apartments. "I would go by this place on my way to the beach and I always thought it was such a nice building."

These days her children, grandchildren, and her first great-grandchild keep Debra busy. "I don't get to see them too much right now because of COVID, but we talk on the phone a lot." Debra can often be found sharing words of support or helping fellow Claridge residents. "This whole COVID thing, it's crazy. We do what we can to take care. I'm just so thankful to HODC and to everyone who helps us."

PERSEVERING IN A PANDEMIC

We Moved! Like those we serve, HODC faced a housing crisis of its own in 2020. The space HODC has rented for 15 years was no longer going to be available. Fortunately, HODC was able to move into a temporary space at The Community House in Winnetka as HODC's board and staff searched for a permanent solution. HODC closed on our first-ever corporate home in November. The purchase of 5340 Lincoln Avenue in Skokie places our staff in a central location to our rental properties, and provides space for expansion while controlling our operating costs.

We Stayed Safe! The Covid-19 pandemic changed business practices at HODC. A PPP loan was obtained. Measures to protect staff and residents included remote work when possible, social distancing and masking, and increased cleaning schedules for the properties. Service coordinators helped residents access food banks, transportation services, support services during shut-downs and slow-downs, and apply for rental assistance programs. Our ground breaking and ribbon cutting events were streamed online.
