As the new President of the Board of Directors for HODC, I am privileged to present our 2024 Annual Report. Thanks to your steadfast support, HODC has reached remarkable milestones, creating lasting impact for individuals, families, and communities.

We were thrilled to break ground on three new developments this past year—Zion Woods in Deerfield; a shelter for young women who survived human trafficking in Palatine; and Taylor Place in McHenry—each representing a foundation of stability for residents with opportunities to thrive.

In 2024, we also celebrated the successful completion of our Key Campaign, an ambitious major gifts initiative that surpassed our goal of \$500,000 to fund pre-development costs for new affordable housing projects. This achievement reflects the generosity of our supporters and the shared belief in HODC's mission to invest in places people call home.

I also want to take a moment to express profound gratitude to our outgoing Board President, William Sholten. Under his tireless leadership, HODC navigated the challenges of the pandemic, emerging stronger, more resilient, and more prepared for the future. I'm also grateful for his continued service on the board as we build on these successes.

Finally, none of this progress would be possible without you—our supporters, partners, and community. Your belief in our mission and your generosity have opened countless doors and changed countless lives.

FROM CRISIS TO HOME...

"The day I received the keys to my HODC apartment at Spruce Village was life-changing. **After years of instability, including living in my vehicle and hotel rooms, I finally had a safe, permanent home.** The fully furnished one-bedroom, complete with a welcome basket of essentials, marked a new beginning.

In 2020, I was in crisis. My disability had worsened, leaving me unemployed and struggling to stay housed. The stress and fear of homelessness, especially during the pandemic, was overwhelming. I applied for affordable housing. During the application process, I worried that every step might fall through. But in January 2021, I became the first tenant at Spruce Village, and relief washed over me like never before.

Now, my child visits me every day in a secure, welcoming environment. The staff, like Dan the property manager, are supportive. The sense of safety—from clean hallways to parking lot cameras—have allowed me to rebuild my life with hope and dignity.

Affordable housing is a lifeline. For me, Spruce Village is a sanctuary, a testament to the **power of human compassion**, and a reminder that even in the darkest of times, **hope can bloom.**"

We are grateful to the individual who bravely shared their story, allowing us to illustrate the power of affordable housing. To safeguard their privacy, identifying details have been omitted.

HODC is **opening doors** and **changing lives** in communities throughout the Chicago suburbs. Families, seniors, single people, and individuals with disabilities each have unique housing needs but share a desire for stability. Affordable housing makes independence, security, and opportunity possible.

FROM VISION TO REALITY:

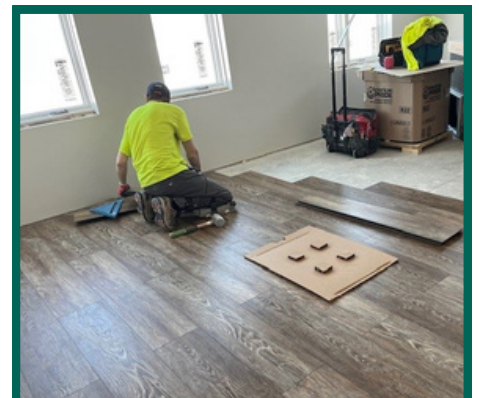

In April, HODC in partnership with Brinshore Development and Zion Evangelical Lutheran Church, broke ground on Zion Woods, a long-awaited affordable housing community in Deerfield, Illinois. **This project, the culmination of over a decade of planning and collaboration, will provide 25 rental homes for families, individuals, and people with disabilities facing housing affordability challenges in the area.** The groundbreaking ceremony was attended by community leaders, including Deerfield's mayor and state officials, who recognized Zion Woods as a significant step towards a more inclusive and accessible community.

Designed with sustainability as a core principle, the development will feature Energy Star appliances, a community garden, and a dedicated play area, all situated on eight acres of green space generously donated by Zion Evangelical Lutheran Church.

Anticipated for completion in June 2025, Zion Woods is poised to welcome its first residents. As construction progresses, the excitement continues to build for the families who will soon call Zion Woods home—people who work in the community but have been priced out, and individuals with disabilities who need accessible and appropriate housing options. With professional property management and access to essential support services, residents will find a community where they can thrive. **Zion Woods stands as a testament to what's possible when vision, perseverance, and collaboration come together to create lasting change.**

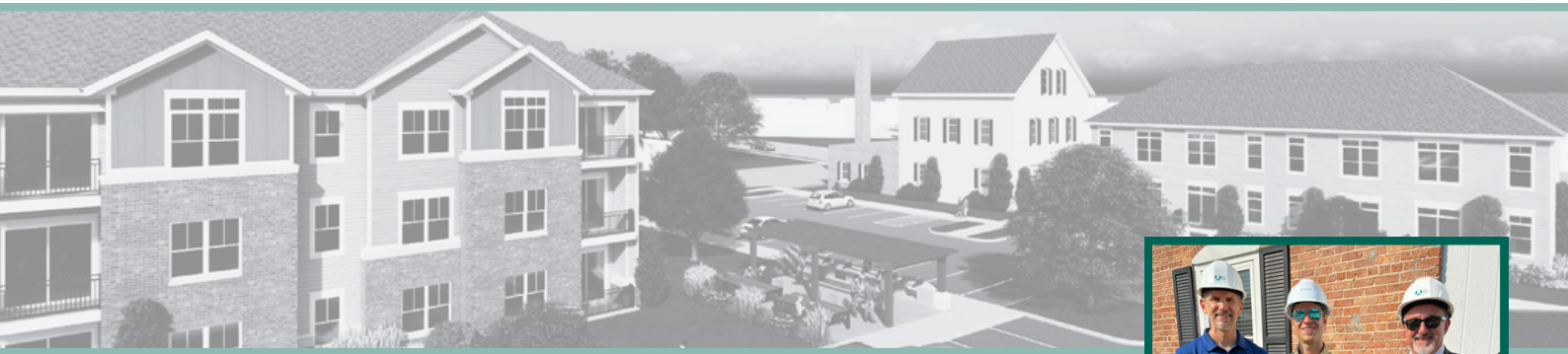
BUILDING FOR TOMORROW

SHELTER, PALATINE

In October, HODC, in partnership with Shelter, Inc., broke ground on Illinois' first DCFS-licensed home dedicated to supporting young female survivors of human trafficking. This pioneering 12-bedroom residence in Palatine will offer a secure and nurturing environment with 24-hour therapeutic support, allowing residents to heal and rebuild their lives. Constructed sustainably using repurposed shipping containers, the home is slated for completion in 2026. This project exemplifies our commitment to addressing critical housing needs in under-resourced communities across Chicagoland.



TAYLOR PLACE, MCHENRY

HODC and Northpointe Development Corporation broke ground on Taylor Place, a new development that will create 54 much-needed apartment homes to McHenry.

Surrounded by supporters, community leaders and partners celebrated the promise of new homes and brighter futures for local families. Adding to the excitement, Congressman Bill Foster officially recognized Taylor Place in the U.S. Congressional Record, highlighting its importance in addressing the housing needs of local workers and their families.

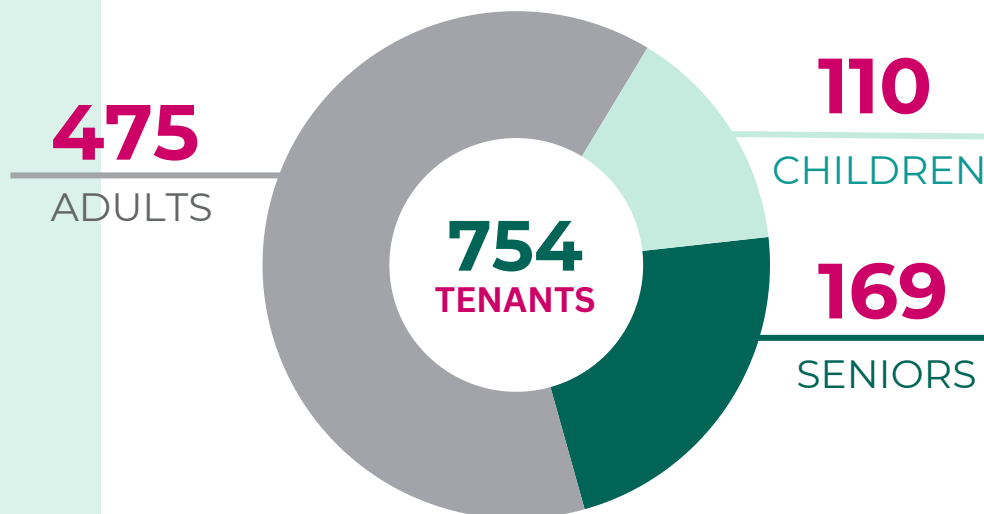
